Basic offer (obligatory):

Service charge (one-time)

First employee (CHF 50.00 will be deducted from the first bill)	CHF	100.00

Administrative charge per account (per person)

For a year's gross salary of up to CHF 25'000.00 7% from gross salary*
(For a salary amounting to more than the above salary amount no administrative charge is made)

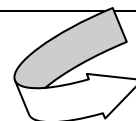

Monthly gross salary (incl. social security contributions)	CHF	1'076.33

We invoice for you as follows:

1. Social security contributions AHV, IV, EO, ALV (12.45%)	CHF	134.00
2. Contribution occupational accident insurance (BU + NBU)*	CHF	26.33
3. Contribution family equalization fund (1.85%)	CHF	19.91
4. Administrative costs (7% incl. 8% VAT)	CHF	81.36

Hourly net wage (Salary to be paid out)	CHF	25.00
Hourly gross wage (incl. social security contributions)	CHF	26.66

We invoice for you as follows:

2. Contribution occupational accident insurance (BU)*	CHF	0.19
3. Contribution family equalization fund (1.85%)	CHF	0.49
4. Administrative costs (7% incl. 8% VAT)	CHF	2.02
